To act as a professional exemplar in carrying out the above duties with a 'can do' attitude.7. To build positive relationships with other staff and colleagues.8. To inform the Service Manager of any changes in the operational environment including customer satisfaction issues.		Key Accountabilities <ol style="list-style-type: none">1. Specified service targets within agreed resources2. Effective supervision of staff to secure high levels of performance3. Alert the Group Manager of issues that could affect performance4. Professional and management support and supervision to a team of staff in a designated work group, for which she/he is appropriately qualified and experienced. This will include the provision of oversight of all team casework.
