<p><b>Job Purpose</b></p> <p>Social Workers will normally be appointed to work in a social care setting, from which they will work as a member of a team. The office base may in some circumstances be changed if the services are subject to corporate re-organisation. Social care services are structured into the first point of contact which is the Multi-Agency Safeguarding Hub at Annesley; Assessment Services in the North and South of the County; the countywide Children’s Disability Fieldwork team based at Meadow House; Locality Teams in Bassetlaw, Newark, Mansfield, Ashfield, Broxtowe and Rushcliffe, and Gedling; and the Through-Care Service based in Ollerton. CAMHS services are provided by County CAMHS Looked After and Adoption Team and CAMHS Emotional Health and well- being team. This team is based at Kirkby in Ashfield but is able to access both NCC and NHS buildings around the country.</p> <p>The County Children Looked After Team and Adoption Team is jointly commissioned by Nottinghamshire County Council and Nottinghamshire NHS Trust. The multi –disciplinary, multi-agency team is based within the Specialist CAMHS Service, Specialist Service Directorate, Nottinghamshire Healthcare NHS Trust.</p> <p>The team is commissioned to specifically work with children &amp; young people who are looked after and living away from their birth parents, in the care of Nottinghamshire Children’s Services.</p> <p>These children and young people may be living with foster carers or living in residential care. The team also offers specialist Consultation and support to children/young people who have been adopted, and their families.</p> <p>It is important to note that the team has a reciprocal agreement with the city team, if a child whom is under the care of NCC moves to Nottingham city we will offer support, in term this will means traveling in to the city.</p> <p>The role in which the team is advocating is a social work post whom will work as a mental health practitioner within the team, with a multidisciplinary team around them. They will with support grow in confident to share understanding and formulations to ensure clear narratives around mental health and Trauma/ attachment are formed.</p> <p>The role as stated below will include, consultation to networks, training and direct work. The post holder will be experienced at holding risk and complex cases, which can at times be challenging and requires a high standard of time management.</p> <p>The post holder will need to work with young people and their networks to ensure string discharge plans are considered at the very start of</p>		

entering the service to ensure empowerment is present and a strength-based approach is demonstrated, holding a child focused approach throughout their time within the team.

The post holder will be offered monthly managerial and clinical supervision.

The post requires the post holder to organise and manage their workload independently, under supervision of the Team Manager.

### ***Key Responsibilities***

#### **Department/Corporate Responsibilities**

### ***Key Accountabilities***

Social Workers will undertake a range of duties in connection with the assessment, and planning of services for children and young people and families/carers to enable children to reach the Every Child Matters outcomes including:

1. Assessing the needs of children and their families.

2. Compliance with legislation and departmental policies/procedures

3. Writing reports, case notes and maintaining other documentation as necessary within the Department's Framework system and taking responsibility for case closure.

4. Maintaining records as required by policy and good practice.

5. Working in partnership with colleagues from a range of different agencies to ensure children and young people are safely maintained in their environment.

6. Participation in team activities e.g. team meetings, case discussion, review of team work.

7. Participation in regular supervision.

8. Contributing as appropriate to practice and service development.

6. This job description indicates the main areas of activity of this post. From time to time, however, other tasks/duties may be required but these will fall within the general area of responsibility and grade of post. Any changes which are of a permanent nature will, following consultation with you, be included in the job description in specific terms and will be formally issued to you.

7. In order to achieve the objectives of the project, the post holder will need to work flexibly, including out of hours when necessary.

9. To take up opportunities for relevant training and development, in accordance with the requirement to evidence continuous professional development.

10. Any other duties which may reasonably be regarded as within the nature of the duties and responsibilities/grade of the post as defined, subject to the provision into the job description in specific terms.

The successful candidate will be expected to:

3. Demonstrate Continual Professional Development in line with HCPC regulations and requirements.

4. Offer mentoring support to less experienced workers.

- Further Post Qualifying Awards (Higher Specialist and Advanced Awards)
- Practice teaching
