The post holder will, as part of a team, assist with the overall delivery of the safe care and management of all staff and resident young people, including the day to day administration, organisation and management of the Unit, within the scope of its service delivery.		
<b>Key Responsibilities</b> <p>To assist with the management of the Home to ensure that it safeguards and promotes the well being of children and young people and enables them to reach their developmental potential.</p> <p>To ensure that services are provided efficiently and effectively within Departmental policy and procedures and statutory requirements.</p> <p>To ensure that managers are informed of significant matters arising in connection with the running of the Home, issues of OFSTED compliance and/or the young people.</p> <p>To represent the Home within and outside the Department and to participate in management processes and other forums.</p> <p>To ensure the Home maintains standards required under section 23(1) of Care Standards Act 2000 and is OFSTED compliant.</p> <p>To maintain a current knowledge of legislation, practice issues and developments locally and nationally in the post holder's field of work, and keep others informed.</p>		<b>Key Accountabilities</b> <p>Manages staff and resources and uses customer feedback and complaints to achieve excellent customer service.</p> <p>Sets a personally high standard of customer service as an example to staff.</p> <p>Takes prompt action to maintain required levels of customer service.</p> <p>Ensures that staff and resources are deployed as efficiently and effectively as possible in line with priorities and taking corrective action where appropriate.</p> <p>Has a sound understanding of effective budget management techniques and can use these where required.</p> <p>Encourages staff to develop ideas for increasing efficiency.
