1. The Occupational Therapy role

Occupational Therapists are responsible for ensuring the delivery of appropriate services to adults and their families, according to their assessed needs. This will include assessing the needs of adults and their carers within the National Care Act 2014 framework. In cooperating occupational therapy eligibility criteria within accordance with National Performance Indicators using set timescales and the creation and implementation of culturally appropriate care plans that demonstrate flexibility and innovative use of resources. Occupational Therapists are required to deliver good outcomes for adults through completing timely assessments and implementing effective care plans that safeguard vulnerable adults.

Occupational Therapists are required to manage multifaceted cases including those requiring complicated equipment and major structural adaptations that keep people and their carer's safe using a person centred approach. Occupational Therapists need to be able to apply advanced knowledge of a wide range of policies in reflective evidence based practice.

Successful candidates will be provided with a comprehensive induction programme, access to training, and other professional development opportunities to enable them to fulfil their role, raise their competency level and progress their career. You will be provided with regular support and supervision from a team manager and have access to the department's policies and procedures.

The service is provided over a seven day period therefore as part of your normal working week you may be required to work weekends and bank holidays which are remunerated at enhanced rates.

Appointment to all posts is subject to an enhanced Disclosure and Barring Service (DBS) check.

Candidates need to hold a full driver's licence and have access to a vehicle, except where they are exempt under the Equality Act (Disability Discrimination Act). All of these posts carry an authorised car user allowance or taxi service for disabled employees.
