The post holder will follow a rota pattern of work which will include a variety of shift patterns including evening, weekend and bank holidays and on occasions awake-night and sleep-in duties.</p>

Must have a minimum of 6 months experience of working with children, young people or adults, either in a voluntary, work or other relevant setting.

Must have an understanding of the safeguarding issues which may impact on people in residential care.

Must have an understanding of physical, emotional, cultural, racial and individual needs in a residential setting.

Must have an understanding, awareness of & commitment to equality issues.

Personal and Professional Attributes:

Commitment to self development and training. Including a willingness to undertake training as identified (Diploma Level 3 qualifications).

Ability to work within a stressful environment and manage own stress.

Excellent time-keeping and sickness record.

Able to demonstrate patience, flexibility, integrity, resilience, enthusiasm and sensitivity within good parenting principles and present as a good role model for young people.

Must be able to work on a rostered basis, including weekend and unsociable hours, which may include sleeping-in duties, bank holiday working and awake night duties.

A high level of personal drive and commitment to excellent customer care and the ability to set an example for other staff

Strong interpersonal skills to gain the agreement and acceptance of others including colleagues, senior managers and customers.

Ability to make decisions and solve problems to meet operational targets, involving devising solutions and prioritising the resources available

Must have some knowledge of, and an ability to manage challenging behaviour.

Ability to engage and provide children and young people to develop interests and skills in a range of social activities.

Must hold a full driving licence

Ability to meet agreed objectives and delivery targets by the effective use of resources.
